Over the past few weeks approximately 70 petitions have been filed concerning the above-captioned General Permits. Attached is a Service List identifying the attorney or representative who filed the petition, and the entity named as the Petitioner. Given the number of Petitioners, the following steps have been undertaken:

1. A file has been opened on all of the petitions as of their respective filing dates.
2. Since the petitions involve substantial and controlling common questions of fact and law, consolidation is warranted. R 324.59e(1)(b). Any objection to this step must be filed with this Office by **August 29, 2008**. The requirement that a filing be served on all of the parties is waived for this submission. Absent any basis to forego consolidation, an Order will be entered to that effect after August 29, 2008. R 324.59e(2).
3. A Status Conference will be conducted on **October 1, 2008, at 1:30 p.m.** in the State Office of Administrative Hearings and Rules hearing room, Constitution Hall, 525 West Allegan Street, in downtown Lansing.
4. One issue for discussion during the Status Conference is the advisability of appointing a representative Petitioner(s). R 324.59e(1)(d). If a party wishes to select a representative Petitioner for the Status Conference, it may do so, in writing, by **September 23, 2008**. That filing must be sent to this Office, with a copy to the selected representative Petitioner. The requirement that a filing be served on all of the parties is waived for this submission.
